Authorizing the Public Works Director to enter into a contract or contracts for the construction of a storm water management facility to be located at Airport West Industrial Park, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MANSFIELD, STATE OF OHIO:

SECTION 1. That the Public Works Director be, and he is hereby, authorized to enter into a contract or contracts for the construction of a storm water management facility to be located at Airport West Industrial Park.

SECTION 2. That total cost authorized by Section 1 shall be paid from the Sewer Fund (#503) Non-Departmental Expenses (503.99.99) Capital Outlay Classification.

SECTION 3. That by reason of the immediate necessity to enter into this agreement for essential storm water management, this measure is determined to be an emergency Ordinance for the immediate preservation of the public peace, health, safety and welfare of the City of Mansfield and its inhabitants and providing it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its adoption, otherwise from and after the earliest time allowed by law, after its passage and approval by the Mayor.
